We are responsible for the **Finnish roads, railways and waterways** and for the comprehensive development of the **transport system**.

We are a multidisciplinary **expert organisation** specialising in transport, and operating under the jurisdiction of the Ministry of Transport and Communications.



Organisation and management of CEF Transport calls and projects

- The **Ministry of Transport and Communications** has the overall responsibility of the TEN-T and CEF Transport
- The **Finnish Transport Agency** coordinates the state's CEF applications and on-going project, the TEN-T team and national call information events, as well as gives general guidance of CEF Transport
 - The Finnish Transport Agency has established a **TEN-T team** to assist in TEN-T and CEF Transport related matters. These activities are supported by the Programme Support Action (PSA) of the CEF. The FTA has tendered the consulting companies **Strafica, Ramboll and Wega** to take part in this team.
- The **Ministry of Transport and Communications** has the responsibility to present the project applications to the Ministerial Finance Committee under the Finnish Government and sign the applications (application form part A)
- The **Ministry of the Environment** approves the application form related to environmental compliance of the project (Application form part C)



- Finnish Transport Agency has organised national CEF Transport call info days. The amount of private sector applications in the CEF Transport calls from 2014 onwards and has significantly increased compared to the TEN-T funding period (2007-2013)
- Cooperation with the Finnish Maritime Cluster (FMC) has been increased and the FMC has also participated in organising the most recent call info days
- The Swedish CEF authorities and relevant stakeholders have also been invited to the most recent national CEF info days to increase cooperation and promote cross-border projects
